Adding Reps

- **Application (CS-018)** — Provide all information requested on form.
- **MD criminal record check authorization form (CS-11)** — Each form must include a legible copy of the driver's license and an original signature.
- **Out of state criminal record check** — If your rep lives or has recently lived in another state, you must provide a criminal record from that state in addition to the Maryland record check.
- **Photo** — An identification card will be produced for each rep. It will expire at the same time as the business license. Once approved, you may send the rep to the address below to have the ID produced. Or, you may submit a small photo along with this form. The photo must depict the rep's face clearly and must be of a size that will allow it to be trimmed to 1" x 1".

Deleting Reps

- **Application (CS-018)** — Provide all information requested on form.
- **Photo ID** — The Rep's photo ID must be returned.
