

## HOW TO GET YOUR NEW SECURE CARD

### GETTING YOUR NEW SECURE CARD

When you apply for a *new* driver's license, learner's permit, or ID card, you will still visit your local MVA office and go through the following steps:

- ◆ Bring required documents;
- ◆ Take any tests required;
- ◆ Have your photo taken; and
- ◆ Pay required fees.
- ◆ You will keep your existing card (if you have one) and you will receive an interim document (receipt), which is valid for 30 days.
- ◆ You will receive your new card in the mail within 7 - 10 business days.

### RENEWING YOUR CARD

As always, we encourage you to "Skip the Trip" to the MVA and renew your driver's license or ID card via web, kiosk and mail. If you choose any of these easy methods, there is no change to the current process. Please remember to keep your old card and receipt until your new secure driver's license or ID card arrives in the mail.

## PLAN AHEAD

Plan ahead to give yourself enough time to receive your new secure card through the mail. You can renew your driver's license or ID card six months before your expiration date.

If you're in a rush, the MVA offers the option to receive your driver's license or ID card the next day through the U.S. Postal Service (USPS), which charges \$15 for expedited delivery. Please note that you must be present and provide a signature when your expedited product is delivered by the USPS.

Make sure you maintain an updated mailing address with the MVA. You can track the delivery of your new license or ID card online at: [mva.maryland.gov/product-tracking](http://mva.maryland.gov/product-tracking). Please wait at least two weeks after your transaction before contacting the MVA if you haven't received your new card.
